BACKGROUND

The aim of the Partnership 'Fair' is to provide an important opportunity to bring together donors, international development agencies and partners with delegates of the 122nd Session of the International Coffee Council. OPENING REMARKS



HE Ambassador Iván Martínez

Prior to his new appointment, Ambassador Romero-Martinez, was posted as Ambassador, Permanent Representative to the United Nations in New York. He is a career diplomat since 1971, having served as his country's Ambassador to various countries, including Spain, Egypt, Morocco, Dominican Republic, Jamaica, Haiti, Colombia, Belgium, Netherlands, Luxembourg, United Kingdom, Sweden, Denmark, Finland, Norway and Ireland.

He also represented his country at the ambassadorial level at the United Nations in Switzerland and at the European Union. Other assignments in his country's diplomatic service include the post of Deputy Permanent Representative to the Organization of American States (OAS). Ambassador Romero-Martinez also held several positions at the Honduras' Embassy in the United States, including that of Counselor, and at the Honduras' Embassy in Canada, where he served as Counselor, Minister Counselor and Chargé d'Affaires. At home, Ambassador Romero-Martinez served as Special Adviser to the President of Honduras with the rank of Secretary of State.

He also received a degree in law and social sciences from the National University of Honduras, and went on to earn a PhD in international relations from the Catholic University of Santo Domingo in the Dominican Republic.

Gerardo Patacconi

Gerardo Patacconi was appointed as Head of Operations of the ICO in January 2018. An Economist-statistician and Agribusiness development expert, after a significant experience with the private sector in manufacturing and banking in Italy, he joined the United Nations Industrial Development

Organization (UNIDO) in 1987 as associate Expert in Papua New Guinea and his latest position was Director of the UNIDO Department of Agribusiness Development. In 2013 he was one of the two shortlisted candidates and run for the election for the post of Executive-Director of the International Sugar Organization (ISO).

At the core of his experience is policy and strategic advice, development, fund raising and management of large-scale operations, Public-Private Partnerships and projects covering the coffee sector and other agribusiness value chains.

Rob Skidmore is Chief of Sector and Enterprise Competitiveness Section (SEC) at the International Trade Centre (ITC) where he leads the Value added to Trade Programme. Under VA2T, ITC teams help SMEs build value through improving customer relationships, creating supportive eco-systems and building firm capabilities. In agribusiness, VA2T facilitates broad-based public private alliances that co-develop and implement solutions covering the full value chain.

ITC's portfolio covers projects in cocoa, coffee, horticulture, coconuts, cotton and specialty crops and ranges from the Caribbean to East Africa to Pakistan and Nepal. In 2018, under VA2T, ITC is conducting a dialogue called "No Such Thing as a Commodity" about differentiation and retaining value at origin including in coffee. In another life, Rob managed private sector development initiatives for US-based consulting firms. He holds an MA from Johns Hopkins SAIS and a BA from the University of Wisconsin.

Aurelia Calabro

Aurelia Patrizia Calabrò, an Italian national, holds a University Degree in International Economy, with a special emphasis on Theory and Policy for Economic Development. She started her career at UNIDO in May 1989 at the Agro-Industries Development Department and during almost 30 years of service, she has specialized in agro-value chains development.

In her last position as the Chief of the Agro-Industries Technology Division, which is part of the Agribusiness Development Department Ms. Aurelia Patrizia Calabrò was responsible for the technology aspects of agro-based industries in textile, leather; wood and agricultural tools for value added and job creation. Emphasis is placed upon the design and implementation of programs to serve sustainable development needs of the agri-businesses and related industries, including environmental requirements. She has worked in more than 30 countries worldwide, particularly in Sub-Saharan Africa and spent over 4 years in UNIDO Regional Hub in the Federal Democratic Republic of Ethiopia.

She is an active member of the Program for Country Partnership in Ethiopia, covering the leather and textile components plus a number of agro value chains like coffee, moringa and cactus fruits. She is the Project Manager of the project entitled: “Improving the Sustainability and Inclusiveness of the Ethiopian Coffee Value Chain through Private and Public Partnership” developed in partnership with illycaffè and Ernesto Illy Foundation, under the supervision of the Ethiopian Coffee Authority and financed by the Italian Agency for Development Cooperation. Since 20 July 2018, Ms. Calabrò has been appointed as UNIDO Representative in Ethiopia, Director of the Regional Hub in in the Federal Democratic Republic of Ethiopia and Special Representative of UNIDO Director-General To the Africa Union and UNECA.

Andrea de Marco

With a University background in international and diplomatic relations Mr. Andrea De Marco is serving within the United Nations Industrial Development Organization (UNIDO) since 2009. After an initial experience as investment and promotion expert in the UNIDO Investment and Technology Promotion office in Italy he has been appointed to Addis Ababa, Ethiopia, for three years as Technical Coordinator of different agro-value chains development projects.

Mr. De Marco is now based at the UNIDO HQ in Vienna and supports the Agro Industry Technology Division Chief in coordinating and implementing projects in developing Countries (e.g. in Ethiopia, Kenya, Mozambique, among others) and in establishing strategic partnerships with the private sector and financial institutions. Steven Jonckheere

Mr Steven Jonckheere has recently been appointed as IFAD's Senior Technical Specialist – Gender and Social Inclusion in the Policy and Technical Advisory Division. From 2014 to 2018 he was the Knowledge Management and Monitoring and Evaluation Officer in the West and Central Africa Division. Before that he worked in other divisions dealing with issues related to land tenure security and rural institutions. Mr Jonckheere has more than 10 years of combined experience in rural development.

Richard Anstead

Richard is the Managing Director of Twin, a non-profit organisation which owns a trading company (Twin Trading). This structure allows Twin to combine trading, marketing, programmes and advocacy in a way that builds market systems to create better livelihoods for farming groups growing coffee, cocoa and nuts.

Twin is all about connecting actors along the value chain, facilitating global and deep partnerships between buyers, roasters, donors and farmer cooperatives; with a shared vision of using trade to enable sustainable and vibrant farming communities to develop and prosper. Richard leads the work of both organisations and is also a non-executive director of Divine Chocolate and Liberation Nuts, pioneering Fairtrade companies which Twin was instrumental in creating.

Prior to joining Twin in 2016, Richard worked for Fairtrade in the UK for over a decade. He was responsible for their Product Management Team to support buyers and growers to connect and work together. As well as working on coffee over this time Richard also led Fairtrade's work in tea, cocoa, sugar, bananas and flowers.
