**Appointment of office holders and
Committee representatives for coffee

Background

1. At its 134th Session, the Council will elect a Chair and Vice-Chair for coffee year 2022/23. A list of Council office holders for previous coffee years is provided in Annex I.
2. Rule 34 of the Rules of the Organization stipulates that the Chair and Vice-Chair of the committees shall normally be decided during the last regular session of the Council during the coffee year. As a general rule, these offices shall alternate each coffee year between the two categories of Members. The Council will elect the office holders and consider the composition of the following Committees for coffee year 2022/23. The current composition is shown in Annex II.
 - Projects Committee (8 exporting Members, 3 importing Members).
 - Promotion and Market Development Committee (8 exporting Members, 3 importing Members).
 - Finance and Administration Committee (6 exporting Members, 5 importing Members).
 - Statistics Committee (8 exporting Members, 3 importing Members).
