**Appointment of office holders and
Committee representatives
for coffee year 2012/13**

Background

1. At its 109th Session, the Council will elect a Chairperson and Vice-Chairperson for coffee year 2012/13. A list of Council office holders for the previous five coffee years is provided in Annex I.

2. The Council will also consider the composition of the following Committees for the next coffee year. The current composition is shown in Annex II.

- Projects Committee (8 exporting, 3 importing Members)
- Promotion and Market Development Committee (8 exporting, 3 importing Members)
- Finance and Administration Committee (6 exporting, 4 importing Members)
- Statistics Committee (8 exporting, 3 importing Members)

3. In accordance with the terms of reference contained in document ICC-106-4, the Committees will select their Chairpersons and Vice-Chairpersons from among the designated Members at the first meeting in coffee year 2012/13. As a general rule, these offices shall alternate each coffee year between the two categories of Members. Annex III contains a list of office holders appointed for the Committees for the previous two coffee years.
