**Exports of all forms of coffee
to exporting countries
Calendar years 2006 to 2008**

Background

1. Information on the volume and value of imports of coffee by exporting Members is requested to be provided on a monthly basis, when available, by form of coffee and by origin.
2. In calendar year 2008, only two exporting Members (Brazil and El Salvador) have regularly submitted to the Organization reports on their monthly imports of coffee. Delays in meeting this request are usually due to the need to obtain the information from the Customs Authorities and/or Central Banks. When the International Coffee Agreement 2007 comes into force, compliance by exporting Members with this obligation will be reported to the Committee on a regular basis.
3. Table 1 shows the volume of total exports of all forms of coffee by exporting countries to exporting countries as the declared destination in calendar years 2006 to 2008. The modest increase in these exports from 2007 to 2008 (3.66%) may, in part, be explained by the lack of detailed information on exports by Côte d'Ivoire in 2008 and, perhaps, partial information received from other exporting countries.
4. Table 2 shows the aggregate volume of exports by all importing countries to exporting countries in the same period, showing an increase of nearly 25% in this volume from 2007 to 2008. This table also gives the share of exports to exporting countries by these origins (exporting and importing countries) and the share of these exports by form of coffee.
5. Table 3 shows exports of all forms of coffee to exporting countries as the declared destination from all origins. The table gives volumes to each exporting country as the declared destination and its corresponding share in the total volume in each calendar year. It also shows that in the period covered, three exporting countries together – Ecuador, Mexico and the Philippines – have consistently attracted around 50% of the exports to exporting countries from all origins.
6. The Organization will continue to monitor the exports to exporting countries from both sources and reports will be prepared to the Committee on a routine basis.

Action

The Statistics Committee is requested to take note of this document.
