**Appointment of office holders and

for coffee year 2016/17**

**Background**

1. At its 117<sup>th</sup> Session, the Council will elect a Chairman and Vice-Chairman for coffee year 2016/17. A list of Council office holders for previous coffee years is provided in Annex I.
2. The Council will also consider the composition of the following Committees for the next coffee year. The current composition is shown in Annex II.
  - Projects Committee (8 exporting Members, 3 importing Members)
  - Promotion and Market Development Committee (8 exporting Members, 3 importing Members)
  - Finance and Administration Committee (6 exporting Members, 5 importing Members)
  - Statistics Committee (8 exporting Members, 3 importing Members)
3. The Council will also appoint the Chairman and Vice-Chairman of the Consultative Forum for 2016/17 (see Annex III for a list of previous Forum office holders). Members of the Core Group for the Consultative Forum were appointed for two years in coffee year 2015/16.
4. In accordance with the terms of reference for Committees contained in document [ICC-115-13](#), the Committees will select their Chairmen and Vice-Chairmen from among the designated Members at the first meeting in coffee year 2016/17. As a general rule, these offices shall alternate each coffee year between the two categories of Members. Annex III contains a list of office holders appointed for the Committees for previous coffee years.
