**Distribuição inicial de votos no Conselho
para o ano cafeeiro de 2020/21 nos
termos do parágrafo 6 do Artigo 12
do Acordo Internacional do Café de 2007
(Calculada aos 22 setembro de 2021)**

Antecedentes

1. Neste documento indica-se a distribuição inicial de votos no Conselho para o ano cafeeiro de 2021/22, que se calculou segundo as pertinentes disposições do Artigo 12 do Acordo Internacional do Café (AIC) de 2007.
2. Para que o Conselho possa decidir acerca da distribuição de votos de cada categoria de Membros no ano cafeeiro de 2021/22, é preciso, nos termos dos parágrafos 3 e 4 do Artigo 12, estabelecer o volume médio das exportações de café para todos os destinos (Membros exportadores) ou importações de café de todas as procedências (Membros importadores) nos quatro anos civis precedentes, ou seja, de 2017 a 2020. O cálculo dos votos dos Membros exportadores e importadores foi feito com base nos dados estatísticos que figuram no documento [ED-2378/21 Rev. 2](#).
3. O Conselho Internacional do Café, em sua 130.^a sessão, decidiu delegar ao Comitê de Finanças e Administração a responsabilidade de aprovar a distribuição inicial de votos para o ano cafeeiro de 2021/22.
4. A presente distribuição inicial de votos, indicada nos quadros 1 e 2, foi feita com base no quadro de Membros da Organização sob a égide do Acordo Internacional do Café de 2007 aos 22 de setembro de 2021.
5. A redistribuição de votos indicada nos quadros 3 e 4 baseia-se nas disposições da [Resolução 470](#) do CIC, que suspende temporariamente os Membros em atraso persistente.
